


Understanding Participation


Taking part in an activity (being participant)

- Transparency
- Accessible
- Inclusive

Media and Information Literacy (MIL Report, 2022)

- The key activities included the mapping and analysing of projects in the databases of the EU Youth Programmes, running an online survey among National Agencies and beneficiaries, and organising focus interviews.
- Topics and connection of MIL to Participation, understanding of gaps within the programmems, recommendations, inspiration and examples

Participation Resource Pool

- Library of resources, practical tools, inspirational projects and practices, NAs page
- Possibility to submit resources
- Cross-sectoral coverage of topics like MIL, civic and human rights education, participatory approaches and practices, youth participation, etc.

Aim 3 - Information:

Increase awareness of the impact of the programmes* on youth participation in democratic life.

Aim 4 - Research:

Encourage a knowledge-based approach to youth participation in democratic life within the programmes* by enabling stakeholders to utilise the findings of research on youth participation.

From Information to Knowledge with participation





Aim 5 - Involvement:

Encourage National Agencies and other actors to involve young people when making decisions about the management and implementation in the programmes*, and to take a quality approach to youth participation when doing so.

Aim 6 - Inclusion:

Dedicate specific attention to the participation in democratic life of young people with fewer opportunities.



"I believe that if we are encouraging organizations to really practice youth participation, we should do it ourselves too."

Understanding gaps

- The priority is important to all sectors, but most readily implemented through SE civic education lessons (1)
- Citizenship Education often focuses on developing young people's competences, but doesn't enable young people to influence/effect some sort of change during the project (2)
- VET is identified as the subsector where the participation priority is least emphasised due to its focus on employment. (1)
- While it is also stressed that "making civic engagement a priority in learning mobility experiences in Higher Education would contribute to the achievement of objectives laid out in the European Strategy for Universities."(3)
- Some NAs recognised facing multiple challenges in involving young people in their work, while others haven't planned or started any involvement activities yet (4)
