



How Erasmus+ and European Solidarity Corps enable youth civic spaces

- Number of grants has risen in the current programming period, this increase has not benefited youth-related civil society organisations and youth organisations as much as other types of organisations.
- Organisations led by young people with fewer opportunities face two layers of disadvantage when accessing the programmes:
 - firstly, the financial structure of programmes may not fully meet the needs of their participants,
 - **secondly**, technical and administrative barriers in the programme favour more wellstaffed and professionalised organisations over volunteer- and youth-lead organisations
- While the number of grants has risen in the current programming period, this increase has not benefited youth-related civil society organisations and youth organisations as much as other types of organisations





How Erasmus+ and European Solidarity Corps enable youth civic spaces

- The vast majority of surveyed organisations indicated the programmes enabled them to support young people to participate in civil society either to a great extent or to some extent. It is important to note that this support mainly relies on individual learning and immediate projects rather than long-term development.
 - To tackle this:
 - The next Erasmus+ Regulation should have more explicit references to youth organisations as main stakeholders of the programme
 - The next iteration of the programme should include a youth chapter with among others: lower administrative threshold, grants targeted to youth organisations or regranting schemes for international youth organisations





Youth Programmes

- Explicit recognition of youth organisations as key stakeholders in the next Erasmus+.
- A dedicated youth chapter with:
 - Lower administrative thresholds.
 - Grants targeted at youth organisations.
 - Regranting schemes for international youth organisations.
- Fivefold increase in Erasmus+ funding to expand its reach from 1% to 5% of the EU's youth population, as per the Draghi Report.

Unsolved issue: EUYD Secretariat?

- A key unresolved issue in the update to the EU Youth Dialogue (EUYD) governance resolution is whether it should have its own Secretariat—and what role that Secretariat should play.
- The EU Youth Dialogue is the largest participatory tool for young people in the EU.
 Strengthening its structure means increasing efficiency, ensuring institutional memory,
 and supporting National Working Groups (NWGs) and Youth Delegates.
- This is why we support the broad call from National Working Groups, Youth Delegates, and the EESC Opinion for a more coordinated EUYD, with the ESG having a political role taking decisions relating to the running of the EUYD process, without getting "bogged down" in administrative and procurement processes.



President Von der Leyen's Youth Advisory Board





Youth Advisory Board

The Board must be democratically legitimate. It must reflect the voices of Europe's youth through elected representatives from the National Youth Councils (NYCs).

- We call upon President Von der Leyen and the European Commission to ensure that the
 Youth Advisory Board is composed of an elected representative from the National Youth
 Council of each Member State, as permanent board members. NYCs are the elected
 voice of young people in their communities with a democratic mandate to represent
 their peers from across the political spectrum
- For the Youth Advisory Board to be cohesive and impactful, it must also be connected to and amplify pre-existing youth participation mechanisms, most notably the EU Youth Dialogue
